How should I bill Humana, and how will I be reimbursed?	Physicians should bill the appropriate vaccine and administration code(s) when these services are rendered to children from birth to 18 years old.			
	The VFC program provides vaccines at no charge to physicians.			
Who is covered under the VFC program	Children from birth through 18 years are eligible for immunization under the VFC program.			
Who can provide these vaccinations?	Any physician who treats children from birth to age 18 and who participates in the VFC program can provide these vaccinations.			
	Effective Aug. 24, 2020, this also includes pharmacy providers enrolled in the VFC program. For more information, please see AHCA's <u>Policy Transmittal: 2020-60.</u>

Will Humana require authorization for services?	No. Vaccine services should be provided without any authorization or referral requirements.

What will Humana's reimbursement be?	Humana will not reimburse for the vaccine if it is provided through the VFC program. Through the VFC program, vaccines are provided at no cost to the provider. Humana will reimburse for the administration of the vaccine. Vaccines available through the VFC program are listed on the final page.
